Our Medical Spanish & Cultural Awareness course will be held at:

El Hotel Seven Crown (Centro Histórico) Revolucion de 1910 No. 1090, Zona Central La Paz, BCS, Mexico

If you wish to lodge at Hotel Seven Crown, you can reserve a room requesting any specific needs you may have by calling the hotel at 011-52-612-122-3747 and ask for Conchita.

The location is within walking distance to the malecón (boardwalk), restaurants, shops, pharmacies, the cathedral, and the main museum.

You are welcome to stay there at a discounted rate for our attendees.

Please contact Conchita at the number above for the rates.

There are several other nearby hotels and Airbnb's available for all budgets.

La Paz is located approximately 2 - 2½ hours by car from Cabo San Lucas. It is a very peaceful, calm "pueblo", without a great number of tourists, and where many locals do not speak English. (Thus... much Spanish practice is involved.) La Paz has an international airport and it would probably be best to check online as to which carrier and location (La Paz or Los Cabos) would offer you the best rates.

If you choose to travel via Los Cabos, you can either rent a car and drive the 120 miles or take one of the shuttles from the Los Cabos Airport to the Bus Depot in La Paz. It will take about 3 hours, but you will enjoy some of the stunning views and the culture of the area. We suggest using EcoBaja Tours for the shuttle, they have the newest, and more comfortable fleet although a bit more expensive than others.

We at Rios Associates always use the following route:

THE CBX, Cross Border Xpress from San Diego to Tijuana Airport.

There is a shuttle from the San Diego Airport to the CBX Border Crossing.

A 390-foot-long covered indoor bridge/building connects a service terminal in San Diego with the Tijuana International Airport. Wheelchairs and free suitcase carts are available.

You no longer have to cross the border on foot and take a taxi. This border crossing connects you directly to the Tijuana airport, without having to go through the city of Tijuana.

A round trip CBX ticket is approximately \$59.00 USD.

You go directly to check in your bags and find the gate.

Volaris airlines flies direct from Tijuana to La Paz and is a 1hr 50-minute non-stop flight.

Once you arrive in Mexico, either La Paz or Los Cabos, you can simply deplane, go through Mexican Customs, and catch a taxi or shuttle (sort of a limousine type service) and ask them to take you to Hotel Seven Crown or to whichever hotel you will be staying at. This should cost approximately \$20 - 25 dollars per person (depending on the peso rate) from La Paz Airport.

You will need your passport to re-enter the US from most countries. At times a \$30 (depending on the peso rate) visa or entry charge is requested when arriving in Mexico. It generally depends on the port and the manner of entry, but, just in case, you may want to come prepared.

Daily Schedule

Our 4-day course is a great opportunity to participate in our full training program and learn in detail about the culture, medical terms, grammar, and key phrases in order to communicate more effectively and efficiently with your Latino patient.

Classes begin every day at 8:00 AM and end approximately at 4:00 PM.

On Monday (last day) we will have covered the essential class material by <u>noon</u> in order to accommodate those who need to leave early for return flights or other commitments.

Of course, those who wish to stay are welcome to do so and we will be there to continue working with you, practicing your newly acquired skills.

You will have daily homework from the textbook as well as "townwork" where you will have the opportunity to meet and talk to the local population getting directions, acquiring pricing information and availability of medications, products, etc. You will also have the opportunity to observe and/or become involved with the local culture, habits, and medical community.

We will also have the hospital tour arranged one of the afternoons.

In addition, we will have a guest speaker who is a well-known and highly regarded physician in the community who is always happy and eager to share valuable information and answer questions.

You will still have time to enjoy the city in the late afternoons and evenings.

There are many activities that can be enjoyed in La Paz and nearby towns:

- •Walk, run or jog on the Malecon (Boardwalk)
- Visit one of the many nearby beaches
- •Boat trip to swim/snorkel with Whale Sharks (if in season) +/- 4 hours
- •Boat trip to swim/snorkel at sea lion's colony +/- 6 hours
- •Boat trip or camping at Isla Espiritu Santo from 8 hours to 2 days (if you decide to extend your trip)
- •Kayaks or SUPs rentals at the bay
- Bicycles rentals
- Hiking trails
- Snorkeling and Scuba Diving
- Visit museums in La Paz
- •Day trip to old mining town of El Triunfo (cafes, shops, restaurants, and museum)
- •Day trip to charming colonial town of Todos Santos (cafes, shops, restaurants, and famous Hotel California)

Please be sure to bring the following:

- 1. Spanish-English Pocket Dictionary (optional but helpful)
- 2. Writing material for taking notes
- 3. Complete Medical Spanish textbook
- Comfortable clothing in general, but at least one semi-formal or professional suit/outfit to be worn when visiting the hospital, residents and/or doctors (i.e. no shorts, sandals or Tshirts, etc. during hospital visits.)

We will send the Text/Workbook to you beforehand but can only do so if you submit your assessment form, which allows us to place you in the proper level.

Fee includes CME Credits and Textbook.

If you are a total beginner, please study the first chapter, as well as pgs. 31, 34-36 and 39-41 in Chapter 2, and pgs 45-47 in Chapter 3 (the more – the better) before coming to class. In this way, you will surely feel more comfortable the first day.
